**RENTAL AGREEMENT- PG 3 OF 3**

1) This contract constitutes an agreement for photo booth rental from Booth Crazy photo booths.

2) Upon signature, Booth Crazy agrees to reserve the date and time agreed upon and shall make no other reservations for that date and time. Therefore, the 50% deposit paid at the time of signing this agreement becomes non-refundable 180 days prior to the event date.

3) Guarantee- Your photo booth will be operational a minimum of 80% of time contracted. This allows for the changing of components in case of malfunction and host breaks. If we fail to provide at least 80% up time, YOU OWE NOTHING. A full refund will be sent to you within 30 days. Acts of God, such as power failure, flooding, etc. are not covered by this guarantee.

4) Accessibility- Booth Crazy photo booths are highly portable. Stairs are not a problem. However, we do need access to the venue 2 hour prior to the event. In addition, there needs to be ample space available for set up. The area needed is 8 feet X 10 feet with an 8 ft ceiling. In addition, a 120volt electrical outlet within 25 feet from desired set up location is required. Upon signature, client takes responsibility that accessibility requirements are met. No refund will be given if accessibility requirements prevent booth operation or delay of booth set up.

5) Booth can be set up outside. A hard flat surface is required. Bare ground or grass is not acceptable. In addition, the area must be protected from wind and rain. If weather poses a risk to equipment, booth operation will cease or continue with limitations. These limitations may include free shooting without the enclosure.

6) Liability- The client hereby holds harmless Booth Crazy with respect to any loss, damage or injury, including attorney fees claimed by third persons, provided that such loss or damage was not caused by the fault or negligence of Booth Crazy Photo Booth, its employees or subcontractors. The client shall be responsible for payment of any attorney fees associated with enforcement of this agreement.
